

INFORMATION ABOUT PERSONAL DATA PROCESSING ACCORDING TO UE REGULATION 2016/679 AND D.LGS 196/2003 (ITALIAN REGULATION)

According to the Regulation 04/27/2016 of European Parliament and Council (afterwards "GDPR") and Italian D.Lgs 196/2003 (afterwards "Privacy Code") it is provided the information about personal data processing in reference to Article 13.

- I. **Controller** is Fondazione Promozione Acciaio (afterwards "FPA"), head office: Via Vivaio 11, 20122 Milano (MI) Italy. VAT number 04733080966, ph. 0286313020, fax 0286313031, e-mail: segreteria@fpacciaio.it
- II. **Purposes of processing** it's sending both paper communications like publications than electronic communications like newsletters regarding events, publications, technical updates and news about FPA's activity with specific reference to the development of the steel construction culture.
- III. Way of processing. Personal data are processed following Article 4 of the GDPR and Article 4 of Privacy Code and, specifically with the aim of: collection, data entry, organization, conservation, consultation, modification, selection, comparison, limitation, elimination and destruction. The processing might be operated by paper or electronic methods. FPA doesn't utilize data for profiling. The personal data are not of particular kind as stated in Privacy Code and are not referred to race, political or religious views, the belonging to trade unions, sexual preferences and health. Neither biometric or genetical data are processed.
- IV. **Recipients**. Personal data are processed by people assigned inside FPA and might be communicated to FPA's members, that will have to follow Article 14 of the GDPR and all the legislations on the matter. Data will not be transferred to third countries.
- V. **Period of storing.** Data are stored for 10 (ten) years. They will be stored by the Controller in its head office and computers/servers.
- VI. Rights of the data subject. As established in the GDPR, Article 13, § 2, letters b, d, e, is hereby disclosed:
 - That the data subject has the right to ask to the controller: the modification, the elimination, the access to personal data (e.g. to verify their correctness), the limitation to use (e.g. blocking of newsletter of forwarding to FPA's members). The data subject therefore has the right of data portability. The data subject shall exert its right contacting the controller at the address stated on I paragraph;
 - That the data subject has the right to lodge a complaint to the Italian public authority: *Garante per la protezione dei dati personali* head office: Piazza di Monte Citorio 120, 00186 Roma, Italy www.garanteprivacy.it;
 - That the communication of personal data, even if not mandatory, it's strictly necessary to the purposes of processing and that incomplete data might invalidate the processing activity.
- VII. The hereby information it's provided in electronic format to the data subject, who commits to receive, view and approve it..
